Flea Market Vendors must abide by the rules and regulations of the Waccamaw Market Cooperative available online at [www.waccamawmarkets.org](http://www.waccamawmarkets.org). Exception will be made for allowing non-handmade items. Site Manager will assign spaces and enforce policies. Vendors must provide their own tables, tents & chairs. There will be no electrical service provided.
