Report Narrative

On 9/25/13, I was called to respond in reference to a fire on Front Street. As I came across the Sampit River Bridge, I could see that multiple buildings were on fire. I arrived on Front Street and helped set up a perimeter that would keep the public safe and assist the fire department in their duties. There were several cars parked near the burning buildings and I worked on making sure everyone was accounted for and safe from the fire. I had SGT Ward talking with business owners and others to determine if everyone attached to the affected buildings had been seen or talked to after the fire started. After everyone was accounted for, we (Investigations and I) turned to locating witnesses and talking to them. It was learned that City Councilman Paige Sawyer was who reported the fire. After speaking to Sawyer, it was learned that the fire appeared to start on the rear deck of the Limpin' Janes Restaurant, located at 713 Front Street. Sawyer stated that he was walking down the boardwalk (as he does most every day) when he saw the fire and called 911. Sawyer stated that he saw a black trash bag laying on the back deck of Limpin' Janes burning from top to bottom. Sawyer then stated he called 911 again because the fire was spreading fast and the fire department had not arrived. Sawyer said the fire jumped to the wall and engulfed it. Sawyer stated that he did not see anyone else around the scene. After learning that the fire appeared to be suspicious in nature because of location and circumstances, I called the South Carolina law Enforcement Division (SLED) to request assistance with the fire investigation. About one hour later, an agent from ATF arrived on scene and stated they were contacted by SLED. Special Agent Mike Hill arrived from SLED shortly there after. I connected the agents from ATF and SLED with SGT Ward.

As the fire continued to burn, investigators focused on the origin of the fire by surveying the scene, taking pictures and locating other witnesses. At one point on scene, we (ATF, SLED, and I) spoke with Brian Shepler, business owner for Limpin' Janes. Shepler stated that the restaurant was closed on 9/24/13. Shepler stated that he did some work at the restaurant on 9/24/13 and cleaned up and left at 1400 hours. Shepler stated that during this work, he used Linseed oil. Shepler stated that he used his pinkie finger to dip a rag in Linseed oil and wipe down wood. Shepler made sure that it was clear only a very small amount of oil was used. Shepler stated that he threw all of the debris and used material into a green trash can on the back deck of the restaurant. Shepler stated that he did not use black trash bags, nor did he leave the bag on the deck. Shepler stated that he washed the back deck down and had the restaurant clean and ready to open.

An agent from SLED and I, went to Central Dispatch and secured a copy of the 911 calls. We also viewed video footage from the cameras at Front Street and Broad Street. There were several cars and people on Front Street two hours before the fire. The only person that gained special attention is a white male who was walking from the East to the West on Front Street with a back pack on his back. This male (as he was near the boat museum) looks back over his shoulder and then turns around going back East. A few minutes later, this individual comes running to the West and runs out of camera view. This takes place somewhere around 0300 to 0400. The video also shows an individual walking East on the Boardwalk at the approximate time that Sawyer stated he walked by and found the fire. There was no other foot traffic on the boardwalk during this time period.

Investigators staged near the fire and waited on access to the fire scene as soon as it was safe too. This was not obtained until 9/26/13. On 9/26/13, Special Agents from ATF, SLED, and investigators from the Georgetown Police Department sifted through the debris looking for evidence at 713 Front Street. By using heavy equipment and man power, we were able to locate several items of interest and secure them for evidence after photographing them. The items of interest were pieces of melted plastic and pieces of steel consistent with that from a green city garbage can. All items removed from the scene were laid out on Front Street and looked at before being discarded. The fire department assisted with washing mud and ash from items. Once the scene was finished it was turned back over to the fire department.

Report Narrative

On September 26, 2013, Inv Gregory conducted a series of interviews in relation to the fire that occurred in the 700 block of Front St on the date of this report. Inv Gregory spoke to the following people:

1. Kerri Vernette Dean resides on a sailboat anchored in the Georgetown harbor, near the rear of the fire scene. Dean resides with Christopher Jay Passauer on the boat. At approximately 5:15 am, Dean stated that she heard a crackling noise and got up to see what was going on. Dean stated that she looked over in the direction of Limpin' Jane's and observed the building on fire. Dean stated that the entire back of Buzz's Roost was engulfed. Dean stated that Passauer blew the air horn to alert the residents of the apartments. Dean stated that she did not notice or hear anything abnormal before the fire.
2. Christopher Jay Passauer, corroborated Deans story and stated that he woke up after and could not tell Inv Gregory anything else about the fire other than he saw the fire engulfing the buildings.
3. Cathy McWilliams, resident of 715 Front, Apt E. McWilliams stated that she was on her deck (over looks back porch of Buzz's Roost) at approximately 12:00 am, when she looked down and saw a white male speaking on the phone. McWilliams stated that the conversation was about a break-in and that he was about to burn something. McWilliams stated that another white male came out and began to speak with the first male. McWilliams stated that a black male then came out and told them that they couldn't be in the area. McWilliams stated that she could not see the people in question and just wanted to let someone know about the event.
4. Lavar Barnett was the manager on duty at Buzz's Roost the night before the fire. Barnett stated that he was the only black male working at the time that McWilliams gave for the incident at Buzz's Roost. Barnett stated that he did not have a conversation with anyone in reference to being on the back porch of the business.

Inv Gregory took photos from the boat and placed the photos in the X file. The interviews with Passauer and Dean were audio recorded and place in the X file. Nothing further.

Report Narrative **On November 4, 2013, Inv Gregory conducted a follow up interview with Cathy McWilliams in reference to information she provided on 9/25/13 after the fire in the 700 Block of Front St. McWilliams who resided in an apartment above Buzz's Roost stated that on the night before the fire, she overheard a white male speaking on the phone while she stood on her balcony that overlooked the back patio area of the bar. McWilliams stated originally that the white male who wore a white t-shirt, shorts and a cap was holding a conversation on the telephone. McWilliams on 9/25/13, told Inv Gregory that she heard only parts of the conversation but the subject was talking about a break-in and something burning. McWilliams stated that she misspoke about hearing the subject stating the part about burning but he spoke solely about a break-in that occurred or was about to occur. McWilliams stated that the white male was joined by another white male who asked the original white male if he had told them about the break-in. McWilliams stated that a black male came out and told them that the section of the bar was closed and they would have to leave. McWilliams stated that both males complied with the request from the black male's request.**

McWilliams stated that she heard the word (burning) repeatedly after the fire and that she might have been confused with all that happened to her losing her apartment in the fire. Inv Gregory asked McWilliams multiple times if she heard the subjects speaking about burning something to which she stated she did not hear them speaking about burning anything. Nothing further.

Report Narrative **On 9/25/2013 at approximately 0600 hours, I responded to Front Street in reference to a fire in the 700 block. Upon my arrival, I secured the area near Front/Orange Street and Front/Broad Street.**

At approximately 0800 hours, I was notified by Cpt. Small that Mr. Paige Sawyer was a witness to the incident and he needed to be interviewed at the Georgetown Police Department (GPD). Mr. Sawyer was then brought back to the GPD CID interview room. Mr. Sawyer stated that on the morning of 9/25/2013, he was taking his morning walk (as he does just about every morning). Mr. Sawyer went onto state that at about 0515 hours, as he was walking east on the Harborwalk, (from Broad Street towards Screven Street), he approached the back side of the Buzz's Roost and Limpin' Janes Restaurant. As he did, he could smell smoke. Mr. Sawyer stated that this is when he looked onto the back deck of Limpin' Janes and observed the fire. Mr. Sawyer stated that he went towards the fire and noticed what appeared to be a black plastic bag burning. Mr. Sawyer stated that the bag was located by the back wall of the restaurant. At this time, Mr. Sawyer called 911 and requested the fire department. Mr. Sawyer also noted that it was only a matter of a few seconds and the fire had started going up the wall of the restaurant, so he called 911 back trying to expedite the fire department.

Once I returned back to Front Street, I met up with an ATF Agent who questioned the owners of Limpin' Janes (Bryan Shepler and Tara Tracey). Shepler stated that the restaurant was closed on Tuesday 9/24/2013, and that he did some cleaning up at the restaurant. Shepler stated that he sanded down some tables and applied some Linseed Oil to the wood finish. Shepler said that he used just a small amount of oil. Shepler stated that after he was finished cleaning the tables, he put the rags and trash in a plastic bag. Shepler then put that bag into the green city trash can which was located at the end of the bar inside of a closet.

At this point, I got up with the Agents from the ATF and Special Agent Mike Hill with SLED as we waited to gain access to the fire scene. This was not obtained until 9/26/2013. On 9/26/2013, Investigators from the Georgetown Police Department along with Agents from SLED and the ATF were able to go through the debris from the fire at 713 Front Street. Items that were collected and photographed from the scene were melted plastic and pieces of steel consistent with that from a green city garbage can. These items were placed into evidence at the Georgetown Police Department.

On 9/27/2013, I interviewed Bryan Shepler at the Georgetown Police Department again. I asked Mr. Shepler to tell me about what he did on Tuesday 9/24/2013 when the restaurant was closed. Shepler stated that Brad Trogdon, John Walters, and he refinshed about 7 of the 15 tables in the restaurant. They sanded them down then used a couple of quarts of Linseed Oil for a shiny finish on the tables. Shepler stated that when they were done, he washed down the back deck and put a couple of rags in the garbage can. One rag had saw dust on it and the other rag had a spot of Linseed Oil about the size of a baseball. Shepler went on to state that they left and went to Brad's house for supper.

On 10/3/2013, S /A Hill (with SLED) and I interviewed Brad Trogdon at the Georgetown Police Department. Brad stated that he arrived at Limpin' Janes at about 10:00 AM on Tuesday, 9/24/2013. Brad brought three quarts of Linseed Oil, two cheese clothes, a paint roller and a paint dispenser he bought from Wal-Mart. This was verified with a Wal-Mart receipt. Brad went on to state that Bryan and he, with the help of John Walters, sanded and refinshed about 12 of the tables in the restaurant (Brad stated he would sand the tables and Bryan would put the Linseed Oil on them). Brad stated that they used about 2 1/2 quarts of oil during the project. When they finished up around 1515 hours, he cleaned up his tools and Shepler cleaned off the back deck. Brad also stated that one whole cheese cloth was used as well as several other bar rags. He knew that the

cheese cloth was thrown away, but was unsure if the bar rags went into the trash can. Brad said that there was a big Rubbermaid trash can at the end of the bar, but he was not certain if Shepler threw the trash in that can. Brad believes the green city garbage can was located at the front door.

On 10/3/2013, S/A Hill and I interviewed John Walters. Mr. Walters stated that on Tuesday, 9/24/2013, he helped Bryan and Brad sand some tables. Walters stated that when Brad's sander broke, he had one and he helped sand a few tables. Walters stated that he was only there a couple of hours and then left to go show some art.

Sgt. Ward has reviewed CCTV video which was obtained from a resident in the 700 block of Front Street on the Harborwalk side. Several hours of video was reviewed. The only person that is seen in the video at the time of the fire is the witness who called 911. The Front Street video showed numerous people exercising or walking on Front Street before the fire. The majority of these individuals were identified and spoke to to see if they had any additional information about the morning of the fire. No new information was learned. There was also a unknown white male with a book sack in the area several hours before the fire. This individual has not been identified. It is unclear from the video footage where the white male exited from or where he goes. Attempts are still underway to identify or locate the white male by using the video footage or still photo's to see if anyone recognizes him.

Through the course of the investigation it has been proven through facts and research that Bryan Shepler did not follow proper safety protocol when dealing with Linseed Oil. Shepler was inconsistent on the amount of Linseed Oil that was placed on the rags. He initially stated that it was the size of his finger tip on the rag and then stated that it was about the size of a baseball. Brad Trogdon, who assisted Shepler, stated that an entire cheese cloth was used along with several bar rags. Shepler eventually stated that 2 ½ quarts of Linseed Oil were used. Shepler did not follow proper safety protocol for disposing of or working with Linseed Oil. Research has shown this type of oil to be a highly combustible material that generates its own heat if not disposed of properly. Although a definitive cause of the fire cannot be determined at this time, the eyewitness accounts and video evidence as to the origin of the fire are consistent with statements gathered during the investigation as to the location of the improperly disposed of Linseed Oil application materials. The investigation has failed to show or uncover any evidence of criminal wrong doing on Shepler's part or anyone else at this time.
